- **1.)** Call meeting to order: Mr. Bolinger called the meeting to order at 4:30 pm. Mr. Bolinger stated they did have a quorum.
- **2.**) **Approval of minutes for May 27, 2021:** Chairman Bolinger asked for the approval of the minutes. Mayor Stanfield made the motion to accept the minutes, Mr. Gibson made the second. Chairman Bolinger requested roll which was as follows:

3.) Comments from citizens:

- 1. Mr. John Turnblazer who was there in place of his son at 112 Mohawk Lane because his son couldn't be there due to driving a truck and being at work. He stated that he had something to say concerning the Air BNB that was on the agenda. Mr. Turnblazer stated that for the last few months the people that were coming in with their side by sides had been running up and down the streets like crazy. Mr. Turnblazer also stated some of the things the renters had done and stated he was worried about his grandkids. He also stated that he did not want the planning commission to vote for these people to be allowed to come in and ruin the neighborhoods of LaFollette.
- 2. Mr. Turnblazers son's mother-in-law was there in place of her daughter. She stated she had two grandkids that lived on the street and had a letter written from her daughter due to her daughter the owner of the house being at work. (A copy of the letter is attached to the end of the meeting minutes.) She stated that it was a dead end quite street, but it was not any more. She stated that she asks the planning commission to take into consideration she has always lived here and worked for the City of LaFollette Electric Department for almost twenty-seven (27) years. She asked for the planning commission to take into consideration the people that actually live here.
- 3. Debbie Henagar at 108 Mohawk Lane spoke up and stated that she has lived there twenty (20) years and has never had to call the police until recently. The renters are constantly zooming by on their side by sides. She stated that she did not like it. She raised her daughter there and it was always quiet and you could sit on the porch, now she dreads coming home on Thursdays and Fridays because she knows that's what she's going to have to look at when she pulls down her street. She stated it was heartbreaking.
- 4. The owner of 113 Mohawk Lane, Stephen Huett spoke up stating that he felt like a pretty vial picture had been painted concerning the rental property. He stated that he could lower the number of guests or they could refuse guests if they did not abide by the rules. He also stated that he had applied for a license and that was what he was here for. He stated they had the State Fire Marshall guy there telling him what he needed to do and they had begun fixing the stuff. He stated they had cameras around the house and would not put up with some of the things that was told had happened there.
- 5. The spokeswoman for Liberty Lodge at 1205 Loop Road spoke up stating that most of her renters were people that wanted to have fun. She stated that they told renters about the local stores and places to visit. Stanfield stated that there were just a few streets that what were open to the side by sides, and four-wheelers, yet they seen them on the four lane which was prohibited.

Mr. Turnblazer asked permission to speak again, and stated that the owners made it sound how great it was about the people on Mohawk Lane the residents were suffering. Mr. Turnblazer stated that the renters couldn't do what they were here at home and that's why they came here. Mr. Turnblazer stated that the picture they painted was not how it really was.

They have to get things under control because they are out of control. Mr. Stanfield stated they were supposed to be insured, tagged, and everything else. Mr. Foust stated that was correct. Mr. Foust stated that the city gave the pleasure of designating the streets and they could take it away from them. Mr. Foust asked how if they did not have a license were they operating.
