At this year's Big Creek Fall ATV Festival, we will be hosting our 3 Organized Rides with a couple different trails this year.

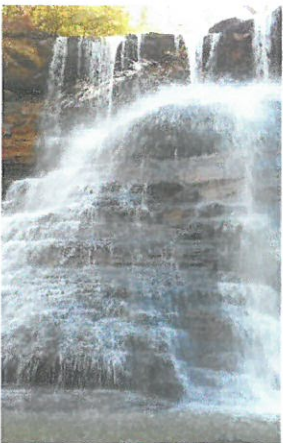
EASY RIDE: The Easy ride will be the same as last year's ride with a trip to the Elk Viewing Tower and a stop at Hickory Creek Falls to see one of our lovely falls, this ride will leave at two different intervals, one at 10:00 a.m. and the next one at 1:00 p.m.



MEDIUM RIDE: Our Medium ride is going up Ollis Creek which is one of the wetter trails on the WMA. This trail features one of the area's oldest cabins as well. About an hour and a half into the trip you will make a rest stop at the 141 exit, then you will go through Meadow Ridge Road then around through Jennings Creek and by another cabin, before completing the ride you will go up Broyles Branch Road, which is one of the most scenic trails with a display of Fall colors on the WMA.



CHALLENGING RIDE: This ride has it all! Everything from scenic creeks, mud puddles and scenic views. This ride also goes by one of the area's oldest cabins and makes a stop at Jennings Creek Falls, then goes to the 141 exit for a rest stop, then comes back onto Flat Woods Road to the City of LaFollette. This ride will take at least 6 hrs. and is for the experienced riders.

RELEASE AND WAIVER

In consideration of being permitted the participate in the BIG CREEK FALL FESTIVAL, the releasor, for themselves and their personal representatives, heirs, and next of kin, releases, waives, discharges and covenants not to sue The City of LaFollette, Tennessee, its officers and members, all referred to as releasees, from all liability to the releasor, his/her personal representatives, assigns, heirs and next of kin for all loss or damage, and any claim or damage, on account of injury to the person or property or resulting in death of the releasor, while the releasor participating in said festival.

Releasor agrees to indemnify the releasee and each of them from any loss, liability, damage or cost releasee may incur due to the presence of releasor in or on City owned/controlled property or during participation in the City sponsored event.

Releasor assumes full responsibility for and risk of bodily injury, death or property damage while using or participating on said City owned/controlled property and/or event. Releasor further acknowledges that he/she possesses the ability to operate its ATV/Utility Vehicle in a safe and proper manner. Releasor further acknowledges that the operation of said ATV/Utility Vehicle is an inherently dangerous activity.

Releasor expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and that if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Releasor, being of lawful age, in consideration of being permitted to participate in the use of said City property and participation in said event, does for themselves, their heirs, executors, administrators, and assigns, releases and discharges The City of LaFollette, Tennessee, their successors and/or assigns from any and every claim, demand, action or right of action, of any kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death and/or property damage resulting or to result from any accident which may occur as a result of participation in the use of City owned/controlled facilities and event, or any activities in connection with The City of LaFollette, Tennessee, whether by negligence or not.

Releasor further states that he/she has carefully read the above release and knows the contents of the release and signs this release as his/her own free act.

This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.

Riding Permits

For a speedy check-in process for the Organized Rides or for solo riding the day of the festival, please visit the State website at www.gooutdoorstennessee.com.

Each vehicle will need a permit and you can print them conveniently at home.

TENNESSEE RESIDENT:

Daily Permit: Type 36, cost \$18.

Annual Pass: Type 1 plus Type 93, cost \$56.

Junior Annual (13+): Type 2 plus Type 93, cost \$35.

Note: A Sportsman license will cover your riding permit.

OUT OF STATE VISITOR:

Daily Permit: Type 38, cost \$40.

7-day Pass: Type 72 plus Type 93, cost \$84.

Annual Pass: Type 71 plus Type 93, cost \$133.

Junior Annual (13+): Type 70 plus Type 94, cost \$36.

Passengers and children 12 and under ride FREE

NEW REGULATIONS FOR OPERATING ON THE ROADWAYS:

Effective July 1, 2017 it is now legal to operate your ATV or SxS on the designated County and City of LaFollette roadways. You can now ride from the trail system into LaFollette for a shopping break and enjoy lunch, ice cream or fuel.

1. Operators must be 16 or older and have a valid driver's license.
2. Operate only during daylight hours.
3. Must stay on designated and posted roads.
4. Must carry proof of insurance.
5. All riders must wear a DOT helmet, goggles and use a seat belt if in a SxS.
6. Must lawfully obey all rules of the road applicable to other motor vehicles.
7. Any vehicle operated in the City of LaFollette shall be operated in a safe manner.
8. Regular safety checkpoints will be conducted to ensure that riders are following procedures.
9. Subject to any and all applicable laws that are required and established by the State of Tennessee.
