ACCEPTANCE OF BID ON EXTRICATION EQUIPMENT FOR LAFOLLETTE FIRE DEPARTMENT

Chief Eldridge advised council that he had received two bids one from Genesis the other from Montro. Chief Eldridge stated that Genesis did not meet their spec requirement and that he recommended the city going with Montro for the amount of \$21,435.94. Motion carried.

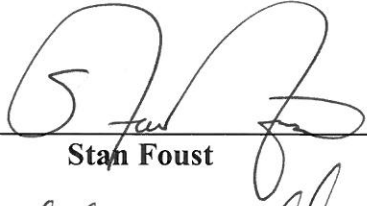

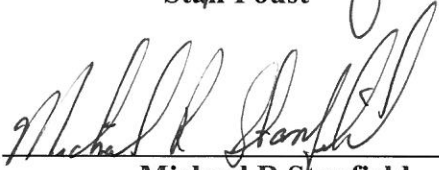
